DIRECTIONS FOR USE

Prior to mixing, SHAKE THE CONCENTRATE WELL FIRST. FOR DISEASE CONTROL: Mix at 1.2% (1.5 oz or 3 tablespoons of concentrate per 1 gallon of water). Reapply every 7 days. For heavy disease, apply and wait 4 hours, then repeat application a second time. Repeat this process every 5 days, as necessary. For preventative maintenance apply every 10 to 14 days. For maximum effectiveness, apply at the first sign of disease. Shake the mixture well prior to spraying. It is best to use a sprayer that emits a fine mist for full coverage of plants and trees. Thoroughly cover the plant you are treating including the front and back of leaves and stems for maximum effectiveness. There is no need to add surfactant.

STORAGE

Keep product at room temperature away from direct sunlight. Do not freeze.

DISPOSAL

Dispose of waste material in accordance with federal, state and local environmental laws and

regulations. Recycle bottle when empty and do not reuse.

PRECAUTIONS/FIRST AID

Avoid getting in eyes or on skin or clothing. Harmful if swallowed. If contact occurs wash with large amounts of soap and water. If in eyes, rinse repeatedly with clean water for 15 minutes. Obtain medical attention for any persistent irritation.

INSTRUCCIONES DE USO

Antes de mezclar, **AGITE BIEN EL CONCENTRADO PRIMERO.**

Mezcle **AL 1.2%** (1.5 oz. o 3 cucharadas de concentrado por 1 galón de agua). Repita la aplicación cada 7 días. Para enfermedades intensas, aplique y espere 4 horas, luego repita la aplicación por segunda vez. Repita este proceso cada 5 días, según sea necesario. Para mantenimiento preventivo, aplique cada 10 a 14 días. Agite bien la mezcla antes de usar. Para máxima efectividad, aplique al aparecer el primer síntoma de enfermedad. Es mejor usar un rociador que emita rocío fino para total cobertura de plantas y árboles. Cubra bien la planta que está tratando, incluyendo el frente y el reverso de las hojas y tallos para mayor efectividad. No es necesario agregar surfactante.

ALMACENAMIENTO

Mantenga el producto a temperatura ambiente, lejos de la luz solar directa. No congele.

DESECHO

Deseche los residuos de acuerdo con las leyes y regulaciones

ambientales federales, estatales y locales. Recicle la botella cuando esté vacía, y no la reutilice.
