#### **DIRECTIONS FOR USE**

Prior to mixing, SHAKE THE CONCENTRATE WELL FIRST Mix 3 oz. (or 6 tablespoons) of concentrate with 1 gallon of water. Reapply every 7 days. For heavy disease, apply and wait 4 hours, then repeat application a second time. Repeat this process every 5 days, as necessary. For maximum effectiveness, apply at the first sign of disease. Shake the mixture well prior to spraying. It is best to use a sprayer that emits a fine mist for full coverage of plants and trees. Thoroughly cover the plant you are treating including the front and back of leaves and stems for maximum effectiveness.

#### **STORAGE**

Keep product at room temperature away from direct sunlight. Do not freeze.

#### DISPOSAL

Dispose of waste material in accordance with federal, state and local environmental laws and regulations. Recycle bottle when empty and do not reuse.

#### **INSTRUCCIONES DE USO**

Antes de mezclar, AGITE BIEN FL CONCENTRADO PRIMERO Mezcle 3 oz. (o 6 cucharadas) de concentrado con 1 galón de agua. Repita la aplicación cada 7 días. Para enfermedades intensas, aplique v espere 4 horas, luego repita la aplicación por segunda vez. Repita este proceso cada 5 días, según sea necesario. Para máxima efectividad, aplique al aparecer el primer síntoma de enfermedad. Agite bien la mezcla antes de usar. Es meior usar un rociador que emita rocío fino para total cobertura de plantas y árboles. Cubra bien la planta que está tratando, incluyendo el frente v el reverso de las hojas y tallos para mayor efectividad.

Mantenga el producto a temperatura ambiente, lejos de la luz solar directa. No congele.
