## MONOBOR-CHLORATE

### THIS IS POWERFUL STUFF!

This is a **NON-SELECTIVE HERBICIDE** so it **KILLS EVERYTHING IN THE SOIL** – grass, weeds, shrubs, flowers and more! You need to be aware of its potential so you will **SAFELY** achieve **GREAT** results.

Controls weeds and grasses, killing existing vegetation and providing a short-season (6-9 months) residual control. Non-selective, broad spectrum, no-spray drift application in a single treatment.

## READ ALL LABELS AND INSTRUCTIONS

### DO's and DON'Ts

- **DO NOT** apply near/onto any desired vegetation
- **DO NOT** apply near/onto any body of water or where runoff will occur
- **DO** pay special attention to sloping terrain and potential runoff
- **DO** water granules into soil if you do not expect at least ¼" rainfall

### WHERE TO USE

**AROUND OR NEAR THE FOLLOWING:** Bleachers, Buildings, Buried cable closures, Catwalks, Cemeteries, Compressor stations, Cooling towers, Electrical generators, Fence lines, Guardrails, Highway & street markers, Loading stations, Lumber yards, Parking lots, Pump decks, Sign posts, Storage & equipment yards, Vacant lots.

**UNDER THE FOLLOWING:** Asphalt, Concrete, Gravel Driveways, Sidewalks or walkways and other similar non-cropped areas.

### WHEN TO USE

Use BareSpot<sup>®</sup> Monobor-Chlorate anytime during the growing season. Weeds and grasses are easier to kill when they are young and growing rapidly.



## HOW TO APPLY

BareSpot<sup>®</sup> Monobor-Chlorate is ready to use! Apply with a hand-operated spreader such as a conventional cyclone type spreader, or a power spreader for larger areas. For smaller areas, apply by hand with the appropriate protective gear. Apply granules uniformly over the area to be treated. Non-agricultural uses are limited to spot treatments with exception of applications under asphalt. Application under asphalt may only be applied with handheld equipment such as rotary spreader and are limited to 8,000 square feet per site. Use on right-of-ways and ditch banks is prohibited. **The material becomes effective in the soil followed by rainfall or watering.**

## APPLICATION RESTRICTIONS & WARNINGS

- **DO NOT** apply over the root system of desirable plants. For trees and shrubs do not apply closer than twice the distance from the trunk to the drip line as roots may be within this area.
- A block, or any fence, will not stop the travel of the herbicide in the soil. Consider the surrounding areas before applying.
- Do not use before planting **ANYTHING** because this product remains active in the soil for 6-9 months.
- Maximum application allowance is 3# per 100 square feet of treated area.

Always use protective rubber or nitrile gloves. Keep people and pets away from product and ALL treated areas until the product has completely dissolved into the soil

## GREENHOUSE APPLICATION INSTRUCTIONS & PRECAUTIONS

**USE ONLY** under plant tables, on walkways and around buildings.

DO NOT ALLOW THE PRODUCT OR TREATED GROUND TO COME IN CONTACT WITH PLANT CONTAINERS OR AREAS WHICH MAY BE UNDERLAID BY ROOTS OF ADJACENT DESIRED GROWTH.

**APPLICATION TO THESE AREAS MAY RESULT IN INJURY OR DESTRUCTION OF THE PLANT.**
