All terms, and policies stated in this proposal supersede any prior published information by Carlin Sales Corporation/ProGreen Plus and/or its representatives for the following programs.

Program Effective:	August 1st, 2021 - July 31st, 2022
Pricing:	Carlin Sales Corporation establishes all published pricing on its products to its customers. For large orders, please see your Carlin Sales Representative for a custom quote. All stated prices are for plant product only unless otherwise noted on specific price documents. All pricing and terms are subject to change without notice. In the event of rising fuel costs, an energy surcharge may be applied.
Early Order Discount:	The 3% early order discount is applicable to rooted liner orders only. EOD deadline is 10/15/21 and must be submitted to Carlin Sales by 10/12/21. Order increases after 10/15/21 will not reflect the EOD pricing.
Order minimums & multiples:	In addition to supplier minimums, Carlin Sales requires a \$500 minimum in combined plant material purchases in order to pre-book. Minimum order is 1 strip. Minimum per variety is 1 strip. Galema does not require even trays or full boxes.
Tags:	Picture labels are automatically included for each rooted cutting at a cost of \$0.05 per tag unless otherwise specified. Picture tags come from John Henry or URC supplier unless not available, then a thermal tag will be included. Tags ship separately via USPS, freight charges will apply.
Royalties:	Royalties vary per variety and are included in the cost of the liner.
Freight Charges:	All orders are considered FOB Galema in West Lafayette, IN. Fed Ex Ground service usually provides the lowest cost service and will be used instead of 2-day if the transit time is the same. Orders will generally be shipped via the method indicated on the broker acknowledgement unless weather conditions would affect plant quality. Generally, Galema Greenhouse ships product out on Tuesdays for delivery on Wednesday or Thursday unless weather conditions are severe (i.e. night temperatures below 20 degrees, snow/ice events, etc.). Orders can be picked up at Galema Greenhouse. A 24 hour advanced notice is required on all orders that are to be picked up. Pool truck shipments for liners are available on a very limited basis. If available, pool truck delivery charges are \$0.05 per liner. If you are interested, please notify your Carlin Sales Representative.
Packing Information and Charges:	Small and medium boxes are a \$7.00 boxing charge and hold 9 - 12, 26 strips or 3 - 4 50/51 trays. Large boxes are a \$11.00 charge and hold 21 - 24, 26 strips or 6 - 8, 50/51 trays. Winter pack is an additional \$5 cost per box for "space wrap." The 3 box sizes are 22"x12"x19" (standard size, 31 lbs), 24"x21"x14" (43 lbs) and 24"x20"x7" (21 lbs).
Custom Varieties:	Galema Greenhouse is willing to root anything included in the Dummen Orange or Plant Source International catalogs with a minimum order of 100 cuttings. Adequate notice is required; a lead time of 12 weeks is requested for items not on our product list. Please contact your Carlin Sales Representative for a custom quote.
Order change and cancellation policy:	No changes will be accepted after the product has been planted / stuck. Acknowledgements will be sent to the customer for each order. Customers should look over the acknowledgements and report any discrepancies to Carlin Sales Corporation. Carlin Sales Corporation/Galema are not responsible for an error that is shipped as acknowledged.
Payment Terms:	Carlin Sales Corporation approved credit customers will receive their standard terms on these invoices. COD customers must pre-pay for their order in full at the time the orders are placed with Carlin Sales Corporation. Any additional trays added to an existing order will have to be paid for at the time of add on. A final payment to reconcile any substitutions, unshipped product, packing and boxing charges, and freight will follow after the product has been shipped. Payment must be made to Carlin Sales Corporation. A carrying charge of 1 ½ % (18% annual rate) will be added from the date of invoice to all past due balances.
Limitations of Warranty and Remedy:	Galema's Greenhouse, Inc. warrants that plants sold shall conform to accepted industry standards within the limits of accepted commercial tolerances. We make no other express warranty concerning the plants. Galema's Greenhouse, Inc's liability for breach of the limited warranty given above is limited to replacement of non-conforming plants or refund of the invoice price of such plants. At no time, shall Galema's Greenhouse Inc. be liable to Buyer for any incidental or collateral damages arising from any breach or alleged breach by Galema's Greenhouse Inc. of the foregoing limited warranty (i.e. lost profits, planting costs, labor or any other incidental or collateral damages sustained, or allegedly sustained by Buyer as a result of a breach or alleged breach of the limited warranty by Galema's Greenhouse Inc.).
Credits:	Shipping related claims must be submitted to Carlin Sales within 1 week of product receipt. Quality related claims must be submitted to Carlin Sales within 14 days of product receipt. Claim must include pictures, variety and quantity claimed. Any claim over \$500.00 requires the physical inspection of the product by a Carlin Sales representative. Galema reserves the right to replace product first and refusal may lead to credit not being issued.
Delays in Delivery:	Carlin Sales Corporation shall not be responsible for loss or damage caused by delays in delivery from weather, strikes, acts of war, fire, casualty, inability to obtain materials, or other causes beyond our control. Galema will hold shipments and notify customer in extreme cold.
