All terms, and policies stated in this proposal supersede any prior published information by Carlin Sales Corporation/ProGreen Plus and/or its representatives for the following programs.

Product Offering:	All unrooted cuttings grown and shipped from Guatemala. Cuttings sold as eaches and shipped as eaches.
Program Effective:	October 02, 2022 - September 30, 2023
Pricing:	Carlin Sales Corporation establishes all published pricing on its products to its customers. For large orders, please see your Carlin Sales Representative for a custom quote. All stated prices are for plant product only unless otherwise noted on specific price documents. All pricing and terms are subject to change without notice. In the event of rising fuel costs, an energy surcharge may be applied
Order Minimums and Multiples:	Minimum per variety is 100 cuttings. Minimum order (without penalty) quantity is 2,000. A \$30 below minimum fee will be applied to orders under 2,000 cuttings. Carlin Sales requires a \$500 minimum in combined plant material purchases in order to pre-book.
Tags / Labels:	Labels are not available.
Royalties:	Royalties vary per variety. Royalties are included in the cost of the URC.
Freight Charges:	All freight charges and import costs are included in the price of the URC.
Packing:	No packing charges.
Order Change and Cancellation Policy:	All order changes should be made at least 21 days prior to shipping. Acknowledgements will be sent to the customer for each order. Customers should look over the acknowledgements and report any discrepancies to Carlin Sales Corporation. Carlin Sales Corporation/Danziger are not responsible for an error that is shipped as acknowledged.
Payment Terms:	Carlin Sales Corporation approved credit customers will receive their standard terms on these invoices. COD customers must pre-pay for their order in full at the time the orders are placed with Carlin Sales Corporation. Any additional trays added to an existing order will have to be paid for in full at the time of add on. A final payment to reconcile any substitutions, unshipped product, packing and boxing charges, and freight will follow after the product has been shipped. Payment must be made to Carlin Sales Corporation. A carrying charge of 1 ½ % (18% annual rate) will be added from the date of invoice to all past due balances.
Credits:	Preliminary claim must be submitted to Carlin Sales within 24 hours of product receipt. Final claim must include pictures, variety, number claimed and if a credit or replacement is preferred. Any claim over \$500.00 requires the physical inspection of the product by a Carlin Sales representative. Delivery of 5% more or 5% less of the amount of plant material as stated in the order will be regarded full completion of the order.
