Pricing:	Carlin Sales Corporation establishes all published pricing on its products to its customers. For orders of 1,000 trays or more, please see your Carlin Sales Representative for a custom quote. All stated prices are for plant product only unless otherwise noted on specific price documents. All pricing and terms are subject to change without notice. In the event of rising fuel costs, an energy surcharge may be applied. Pricing does not include labels, boxes or royalty/patent charges.	
Volume Pricing:	See price list for volume breaks. Based on quantity shipped per plug size, per ship date.	
Order Minimum:	4 trays. Orders of 2-3 trays subject to \$40 below minimum fee. Orders of 1 tray are not accepted. Carlin Sales required a \$500 minimum in combined plant material purchases in order to pre-book.	
Vernalization (Cold Treatment):	Swift's 50-plugs are shipped actively growing in September – October and have not been vernalized. Most plugs shipping from January through March have been fully vernalized for predictable flowering and growth. Many items are held in cold storage and shipped dormant through May. Swift's 275-plugs shipped from availability / overages December - April are often cooled / dormant or semi-dormant with yellow and/or brown foliage. This is normal & will disappear with warm night time temperatures above 65F. 275 Plugs Pre-ordered (ordered with at least 2 months advance notice) are sown to order and are actively growing when shipped.	
Tags:	Available on 50 plug trays only. Tags will be shipped unless otherwise specified at a cost of \$0.1199 per tag. Tags are custom tags from John Henry Junior Portrait locking tags. They are included in the shipment. Tags ship at a ratio of 1:0 or 1:1 only.	
Royalties:	Royalties vary per variety. Royalties are a separate charge per plug.	
Freight:	All orders considered FOB Swift Greenhouses in Gilman, IA. All shipping methods are at the customer's risk. Carlin Sales Corporation/Swift Greenhouses has no control over weather or other naturally occurring events that may delay or damage product. In extreme cold, Swift Greenhouses will hold shipments and notify the customer. FedEx ground is used on most 50 Plug tray orders and FedEx 2nd Day Air for most 288 Plug tray orders. Swift Greenhouses Grower Truck is used for most IA, IL, IN, MI, MN, MO, & WI orders in February and March if over 100 trays.	
Packing Information and Charges:	Even packing is not required or guaranteed. Trays per case vary depending on plant height at time of shipping. 50 Plug trays are packing 3 - 5 trays per case. 288 Plug trays are packed 4 - 7 trays per case. Boxes are 22"x12"x16" and weight approximately 31 pounds. There is a cardboard charge of \$8.00 per box. There is no charge for packing or cold weather packing.	
Order Requirements:	Acknowledgements will be sent to the customer for each order. Customers should look over the acknowledgements and report any discrepancies to Carlin Sales Corporation. Carlin Sales Corporation/Swift Greenhouses are not responsible for an error that is shipped as acknowledged. Ship dates on acknowledgements indicate the ship WEEK, not the actual ship day.	
Order Changes:	Changes to existing orders and new orders are allowed up until order processing begins, usually 3-5 days prior to shipping. However, during the busy season (January – April) changes to orders will not be permitted once order process has begun, up to 12 days prior to order ship date.	
Order Cancellation Policy:	No cancellations are permitted on 50 Plug material after February 1, 2022. No cancellations are permitted on 10 trays or more of individual 50 Plug items after they have been held and acknowledged for three months or longer. Cancellations are not permitted on 288 Plug Tray orders once they are sown.	
Payment Terms:	Carlin Sales Corporation approved credit customers will receive their standard terms on these invoices. COD customers must pre-pay for their order in full at the time the orders are placed with Carlin Sales Corporation. Any additional trays added to an existing order will have to be paid for at the time of add on. A final payment to reconcile any substitutions, unshipped product, packing and boxing charges, and freight will follow after the product has been shipped. Payment must be made to Carlin Sales Corporation. A carrying charge of 1 ½ % (18% annual rate) will be added from the date of invoice to all past due balances.	
Limitations of Warranty and Remedy:	The purchaser's exclusive remedy for any claim or loss resulting from breach of warranty, breach of contract, or negligence shall be limited to the repayment of the purchase price. Carlin Sales Corporation/Swift Greenhouses shall not be responsible for the loss of any product profit, or any indirect, special, or consequential damages. We give no other or future warranty, expressed or implied, and all other or further warranties, including any warranties or merchantability of fitness for a particular purpose are excluded.	
Credits:	Certain varieties require special conditions in order to grow and perform properly. Varieties requiring long days and warm night are marked on this list with a 'light bulb'. Swift also provides a 'Growing Recommendations' sheet with every order shipped that specifies the varieties and the necessary growing conditions for those varieties. If these instructions are not followed, Swift and/or Carlin Sales Corporation cannot be liable for any losses and/or claims. Preliminary claim must be submitted to Carlin Sales Corporation within 48 hours of product receipt. Final claim must include pictures, variety, quantity claimed and if a credit or replacement is preferred. Any claim over \$500.00 requires the physical inspection of the product by a Carlin Sales Corporation representative. Tags can be returned with prior notification. A 25% restocking fee and freight will be charged if labels are returned. Credit will only be given on full, unbroken packs of labels upon their return to Swift.	
Delays in Delivery:	Carlin Sales Corporation shall not be responsible for loss or damage caused by delays in delivery from weather, strikes, acts of war, fire, casualty, inability to obtain materials, or other causes beyond our control. Swift Greenhouses will hold shipments and notify customer in extreme cold.
